## Site Plan Application Check List

### REQUIRED WITH THE APPLICATION FORM:

#### **Supporting Documents:**

- Detailed letter of intent describing proposed use of property.
- Class A-2 survey map of the subject property.
- Site Plan in accordance with Section 5.2.2 of the Redding Zoning Regulations. Note that the Commission may waive portions of the requirements of Section 5.2.2 if the information is deemed to be unrelated to the present application.
- List of project professionals.
- List of directly abutting property owners
- In accordance with Connecticut General Statutes Section 8-3i: any project located within a public water supply watershed area must notify the applicable water company (Aquarion) and the State of Connecticut Commissioner of Public Health of the proposed project. Aquarion notification form follows on Page 3. For information on the state notification, see page 4. Proof of the notifications must be provided with the application.
- The commission reserves the right to request additional information required to confirm compliance with the Zoning Regulations of the Town of Redding.

#### **Fees:**

Site Plan Approval, Residential Zone	\$175.00
Site Plan Approval, Commercial Zone	\$50.00 for up to \$5,000 estimated project cost; \$5.00 additional for each \$5,000 of project cost thereafter
State of Connecticut fee: all applications	\$60.00

In addition, the applicant is responsible for the costs of all legal notices and certified mailings as required by the Connecticut General Statutes.

### ADDITIONAL APPROVALS REQUIRED:

For projects that need approval from the Water Pollution Control Commission or the Conservation Commission, a decision may not be made by the Redding Zoning Commission until those approvals are obtained.

**Note: Site Plan approvals granted by the commission are approvals for the use of the property; any actual construction requires administrative approval from the Zoning & Building Departments.**

## **PUBLIC WATER SUPPLY CT DEPARTMENT OF PUBLIC HEALTH NOTIFICATION REQUIREMENTS**

Effective October 1, 2006, applications for any project located within a public water supply watershed area before the Zoning Commission, Zoning Board of Appeals, Planning Commission, or the Conservation Commission must notify the Commissioner of the Connecticut Department of Public Health (CTDPH).

In order to determine if your project is in this area, consult the ***“Public Drinking Water Source Protection Area Map”*** on file in the offices of the Redding Town Clerk, Land Use, and the Redding Zoning Enforcement Officer. If your project falls within this area, please follow the notification process detailed below:

1. Go to the CTDPH web form submission page at [http://www.dir.ct.gov/dph/Water/Web\\_form.htm](http://www.dir.ct.gov/dph/Water/Web_form.htm)
2. Click on “Watershed or Aquifer Area Project Form”
3. Complete the form on this page.
4. Submit the form by clicking on the “submit” button
5. Print out your confirmation form and submit a copy with your completed application materials.

If you do not have internet access, you may obtain a copy of the reporting form from the Town of Redding Zoning Office: the form may be completed and mailed to the state at the address shown on the form.
