CALL TO ORDER

T. Johnston called the Region 9 Board of Education Annual District Meeting to order at 7:01 p.m.

NOMINATION OF MODERATOR TO CONDUCT THE MEETING

T. Johnston nominated Susanne Krivit to conduct the meeting.

ELECTION OF THE MODERATOR

S. Krivit was elected unanimously to conduct the meeting.

MODERATOR TO READ THE CALL OF THE MEETING

S. Krivit read:

“Warning is hereby given to the electors and those persons eligible to vote in district meetings of Regional School District No. 9 (the “District”) that the District’s Annual Meeting will be held on Monday, May 6, 2024, at the Joel Barlow High School Library Learning Commons, 100 Black Rock Turnpike, Redding, Connecticut 06896 at 7:00 p.m., for the following purpose:

To present the proposed budget in the amount of \$25,407,041 for Regional School District No. 9 for the fiscal year from July 1, 2024 to June 30, 2025. Of which Easton’s share is \$13,419,999 – an increase of \$163,286, or 1.23%; and Redding’s share is: \$11,987,042- an increase of \$432,388, or 3.74%. The apportionment percentages for the two town is as follows: Easton 52.82%- a decrease of .61%; and Redding 47.18%- an increase of .61%

The Moderator shall adjourn the Annual Meeting at its conclusion and the budget shall be submitted to a vote upon the voting tabulators in the District’s member towns of Easton and Redding on Tuesday, May 7, 2024, in accordance with Section 10-51 of the Connecticut General Statutes, between the hours of 6:00 A.M. and 8:00 P.M., under the following heading:

“SHALL REGIONAL SCHOOL DISTRICT NO. 9, COMPOSED OF THE TOWNS OF

EASTON AND REDDING, APPROPRIATE AND AUTHORIZE THE EXPENDITURE OF \$25,407,041 AS THE OPERATING BUDGET OF THE DISTRICT FOR THE PERIOD OF JULY 1, 2024 TO JUNE 30, 2025? (EASTON'S SHARE IS \$13,419,999 AND REDDING'S SHARE IS \$11,987,042)
